# Dear Dock Customer:

Spring is just around the corner which means it will not be long before the boating season begins. It is very important that you respond by March 15, 2020 to renew your spot, and to take advantage of the early pay discount and be included for the drawing for a free slip. If you wish to move closer or upgrade please respond immediately so that we may best fulfill your request. New dock customers may lease docks now, however, placement will be made, after the deadline, in the order in which payments are received. After the assignment, slips will be leased on a first-come-first-serve basis.

Remember, when paying a one-time payment in full you can take advantage of the discount listed below, otherwise, a 50% deposit is required to reserve a slip. For your convenience, payments may be made by providing credit card information below or enclosing a check or money order. Please do not mail cash. In consideration for our customers who need a payment plan, we have extended the balance due date to June 1, 2020, after which time finance charges will accrue. A \$100.00 fee will be retained for all slip cancellations.

Note to lift customers: It is your responsibility to provide accurate weight (including wake tower) and length of your boat to the marina office for proper placement. If your boat is not fiberglass, we need to know whether it is a pontoon or a tritoon.
